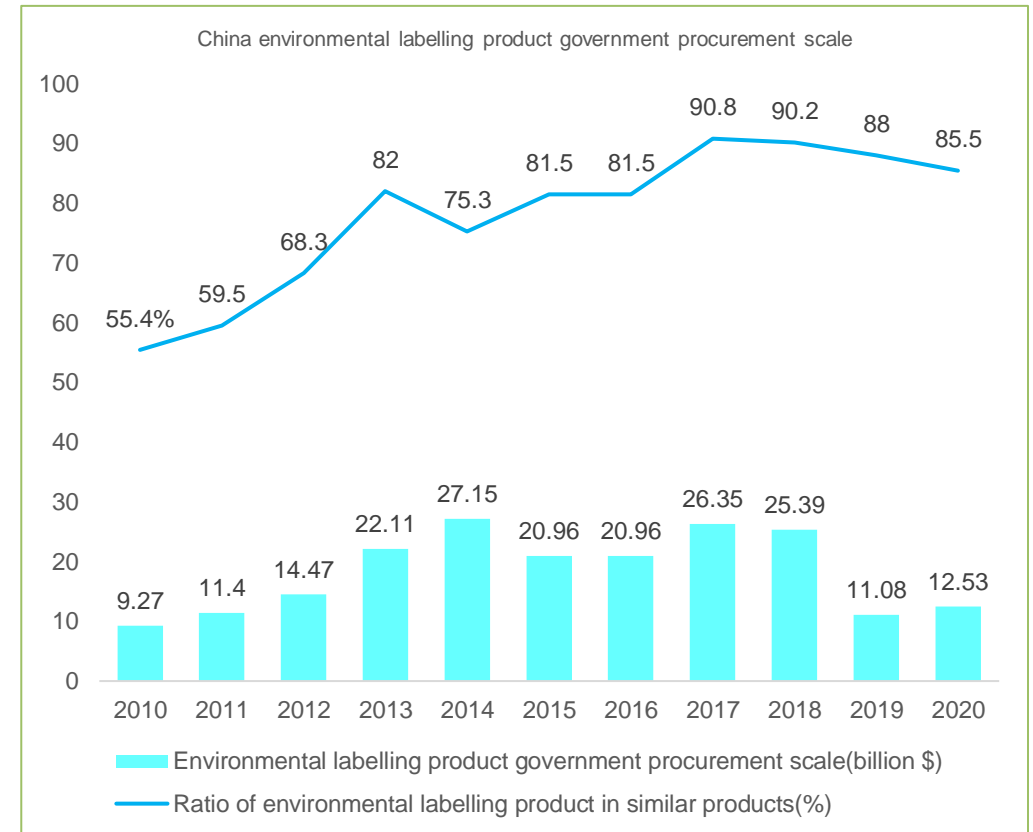

- ✧ The 6th time for us to win the award of 2021 due to its great and continuous efforts in certification of China Environmental Labeling products and contributions to national government green procurement.

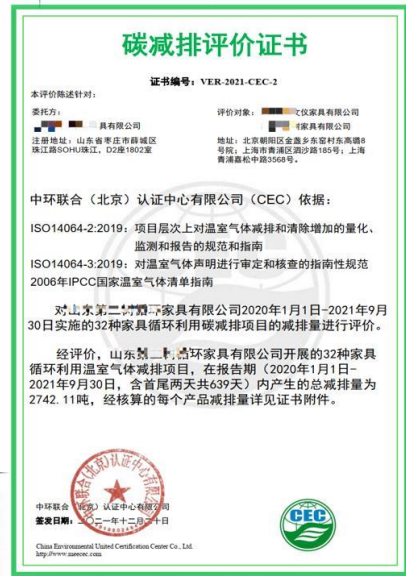
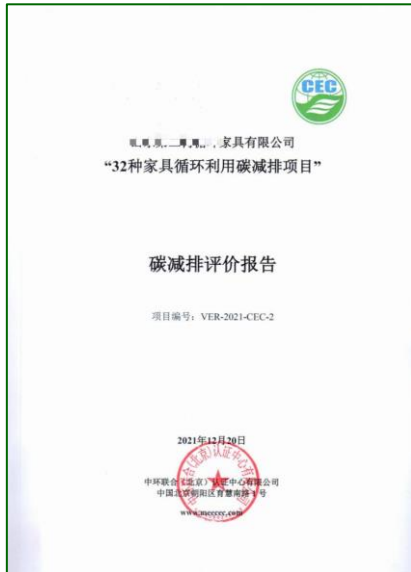
First Zero Carbon Public Procurement Event

First Carbon Reduction Enterprise Certificate



- ❖ Issued the first circular furniture enterprise carbon emission reduction assessment certificate;
- ❖ In accordance with <ISO14064-2:2019: Guidelines for Quantification and Reporting of Project-Level Greenhouse Gas Emissions and Elimination> and <ISO14064-3:2019 Guidelines for the Validation and Evaluation of greenhouse Gas Claims>
- ❖ Based on evaluation, the project generated a total emission reduction of more than 2,000 tons during the reporting period.

- ❖ Perform the Low-carbon Management of Pre-Games Report for the Beijing 2022 Winter Olympic and Paralympic Games



- ❖ The 19th Asian Games in Hangzhou 2022;

- ❖ The 37th Shenzhen International Furniture Design Exhibition is the first "carbon neutral" furniture fair in China, in accordance with <Carbon Neutral Implementation Guidelines for Large-scale Events> issued by MEE in 2019;
- ❖ Issued certificates to the first four enterprises have passed the "Green public procurement demand standard" of MoF.

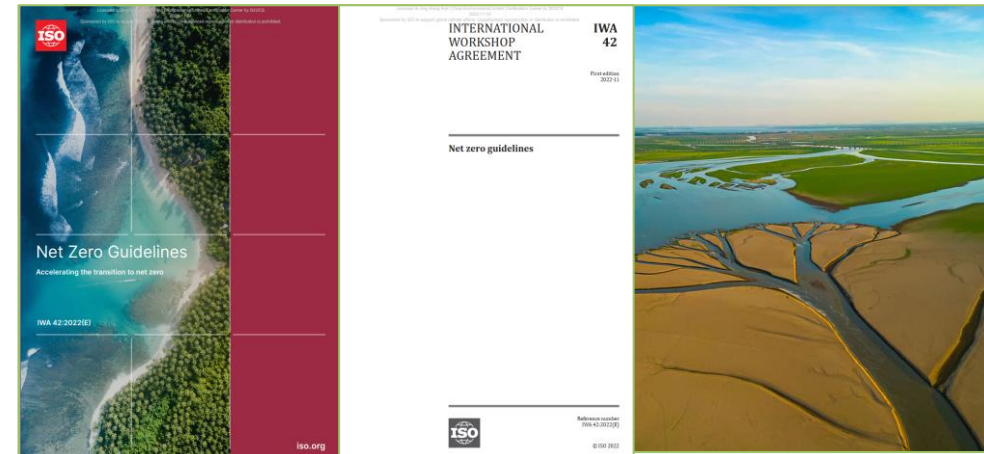
● Lead Carbon Management CCAA Standard

- ✘ <Carbon Management System-Requirement> (T/CCAA 39-2022) issued by China Certification and Accreditation Association;
- ✘ We led and organized 34 institutions from industry, university, research and application



● Participate in ISO Net Zero Guidelines

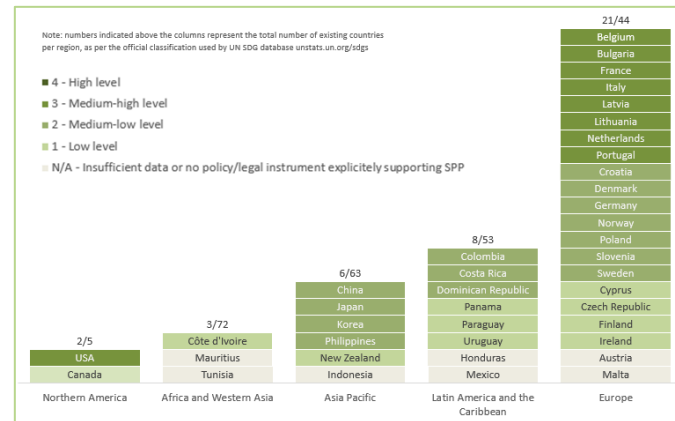
- ✘ ISO launched the International Workshop Agreement on the Definition of Net Zero (IWA) in June 2022 to develop the world's first consensus-based net Zero guidelines.
- ✘ CEC was invited to attend and discussed the draft and related principles with more than 800 colleagues from hundreds of institutions of nearly 100 countries



Featured Activities

Participated in the UNEP SDG 12.7.1 indicators reporting

- ✘ In February 2022, the UNEP released the report of <2020/2021 Data Collection for Sustainable Development Goal 12.7.1>, to assess and demonstrate the maturity level of 40 countries of implementing sustainable public procurement policies and action plans ;
- ✘ CEC, as one of UNEP SPP Program Co-lead, participated in the formulation, pilot validation and evaluation of the SDG12.7.1 methodology;
- ✘ Of the 40 participating countries, China was evaluated as maturity level 2, similar with Sweden, Germany, Denmark, Norway, Japan, South Korea, in line with the mainstream of international sustainable public procurement practice;

✧ On September 26-27th, the China-Japan-Korea Working Group meeting on Environmental Labelling was successfully held online.

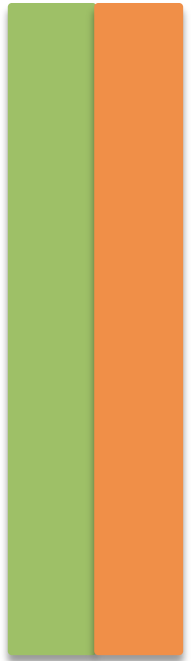
✧ The meeting reached consensus on the common criteria of environmental labelling wallpaper among China, Japan and Korea, updated the common criteria for MFD.



Way forward



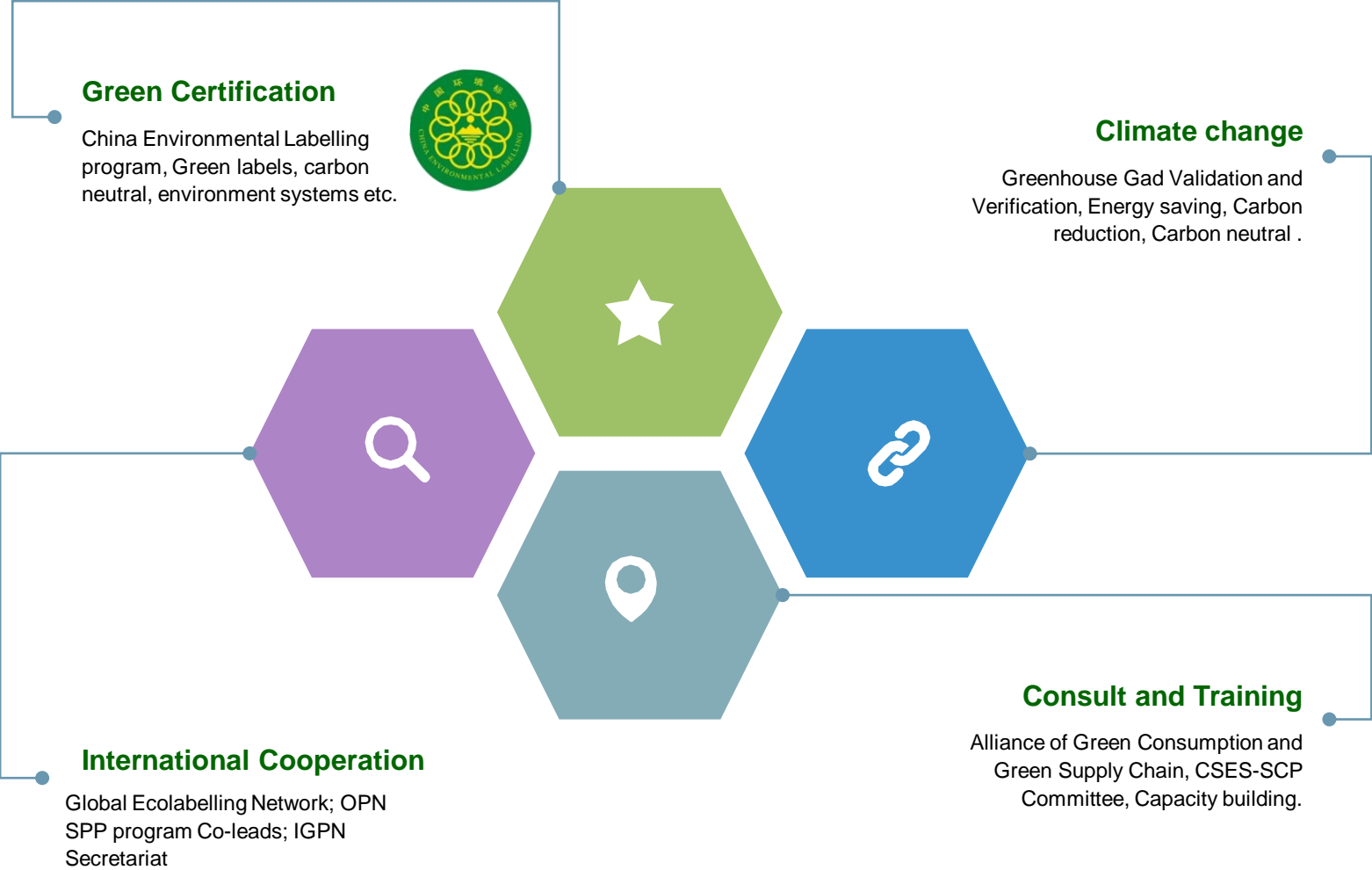
